  1. Title

  4. Department/Program
  5. University Name

- Figures, Illustrations, and Formulas may be inserted within the document, as long as they remain within the space provided
- Digital copies of the abstract and Power Point presentations must be submitted (email submission is acceptable) and no hard copy is necessary
